INGREDIENTS: Water, Natural Flavors, Caramel Color, Glycerin, MSG, Salt, Potassium Sorbate.

BSE/TSE: The product listed above is not animal-derived, contains no ingredients of animal origin, and is free from Transmissible Spongiform Encephalopathy (TSE) and Bovine Spongiform Encephalopathy (BSE).

NON-GMO: The product named above is GMO-free. It contains ingredients derived from crops for which GMO crops are commercially available and has not been tested with PCR technology, but to the best of our knowledge, these ingredients are refined and do NOT contain any GMO proteins or DNA.

VEGAN/Vegetarian: Many natural flavor chemicals are found in a variety of sources that may incur a source that could contain animals (i.e. a fruit flavor may contain a smoothing effect from a chemical with dairy or egg origin). This flavor does not contain animal proteins; however, it may subsequently have origins from dairy or eggs.
